

Friends of MVYRADIO “Beach Bag Giveaway” Sweepstakes Rules

July 2024

Eligibility: **NO PURCHASE OR FINANCIAL CONTRIBUTION IS REQUIRED TO ENTER OR TO WIN. MAKING A PURCHASE OR CONTRIBUTION WILL NOT IMPROVE AN INDIVIDUAL’S CHANCES OF WINNING.** The “Beach Bag Giveaway” Sweepstakes (the “Sweepstakes”) is open to all legal U.S. residents who are at least eighteen (18) years of age, except employees, directors and officers (or any persons who have been employees, directors or officers in the past twelve months) of MVYRADIO and the immediate families or household members of each employee. Eligibility is limited to entrants in the Continental US, or who can claim the prize within the Continental US. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited or restricted by law or regulations.

Dates: The Sweepstakes begins at 6:00 a.m. Eastern on Monday, July 1st, 2024 and will end at 6 p.m. ET on Saturday, July 13th, 2024. (“Sweepstakes Period”).

How to enter: any eligible individual who makes a single donation of \$100 or more, or becomes a Sustaining Donor at the \$10 a month level or more, during the “Sweepstakes Period” is automatically entered for the first drawing. Current Sustaining Donors are automatically entered.

Winners will be required to sign and return an affidavit of eligibility, and liability release within fourteen (14) days of notification or prize will be forfeited and awarded to an alternate winner. Odds of winning depend on the number of eligible entries received. Limit of one (1) prize per individual/household per year from MVYRADIO.
